B Mask Mandate Discussion

Susan Gruen:

- We're at low risk. 5.4, 6.66, 7.09 %. Numbers for Heath are zero. We are the only town with a mask mandate.
- FRCOG has no plans to vax 0–5-year-old. Boosters likely in September.
- Lift mask mandate, explain to people if surge goes up, mask mandate may return. It's up to people to make their own assessment.
- Has 90 test kits. January expiration last another 3 months. Given out to Church, Library, JR, PO and Claire. Sue Lively will get some to COA for their home visits.
- PCR tests are available in Shelburne, and GCC.

Elissa Viarengo:

- Covid numbers are going to go up and down. People should be able to make their own decision about their risk assessments.
- It's the BOH responsibility to educate them on how to do that. We are no longer in an emergency. It's time to move forward.
- Thinks we should provide information and mail it to every resident.

Susan Gruen:

• We should see what FRCOG has as far as material
