## **Heath Council on Aging 2025 Annual Report**

### **Age and Dementia Friendly Community**

Lyra Johnson-Fuller is completing the AARP's required six hourly online classes. We still need one more person to do so.

The Council continued to work throughout the year on preparing the Heath Action Plan for LifePath's eight domains. Goals and actions were identified for the first four domains:

Domain 1: Outdoor Spaces and Buildings.

Domain 2- Transportation.

Domain 3-Housing.

Domain 4-Social Participation.

Plans were started for a board-wide emergency planning group to identify needs and ways to meet them. An idea was introduced to create an outdoor patio area in front of the senior room with tables for seating.

The Council expresses gratitude to Gene and Cindy Garland for donating a window air conditioner for the senior room, and to Pat McGahan for her work on the COA town website.

### **Finances**

The Council continued to work on the handling of accounts, and a need for more fund raising was identified. The following grants were awarded:

Fred Wells Trust: \$1,000 for foot clinic.

Heath Cultural Council: \$280 for a beginner's painting workshop.

Renewal of two LifePath grants: \$1500 for the foot clinic; \$2,241 for the chef's senior meal wages.

The F26 Budget proposal due January 29 was completed as follows: Expenses: \$250; Operating Account: \$500; COA Stipends: \$1750; Foot Clinic: \$1500; Meals Revolving Fund: cap for \$10,000.

### **Activities**

The Council received positive evaluations for the monthly senior meals. It was decided to hold a meal in December for the November/December holiday season. The red chairs originally purchased for the senior meals in the Community Hall were cleaned and moved to the municipal cafeteria. The monthly brownbag lunches continued in the senior room, and the open senior room every Saturday during library hours for intergenerational socializing and refreshments. The Council offered a walk-safe program in JRMC, and co-sponsored the annual winter solstice celebration with the Heath Public Library.

Further activities included"

a weekly taichiquan class and bi-monthly Needle/Arts group;

a well-attended spring natural history walk in the Cook State Forest and a fall hike in Rowe with Bill Lattrell;

egg decorating and silk painting with Sue Draxler and scrapbooking workshop with Eileen Lively supported by the Heath Cultural Council, with an additional beeswax workshop with Eileen Lively;

a grief support group;

a veterans' informational meeting in September and celebration on Veterans Day with Heath representative Gene Garland.

By request, a weekly men's group was started on Fridays. In May, the Council hosted an ice-cream social for the Heath Library story-hour children and all ages. Regular articles appeared in the *Heath Herald*, monthly flyers circulated to inform residents of activities, and announcements sent to those on the Council's email list. At the end of the year, the Rowe Council on Aging reached out to Heath to suggest joint activities, and two members attended the Rowe meeting to confirm our agreement to pursue them.

Donations were gratefully received to support our activities.

And, with thanks to our Senior Program Coordinator, the Council won first prize for its Heath Fair display!

### Finance Committee request

The Finance Committee has fielded some calls from a concerned Heath senior citizen with questions about 1) how the tax rate is calculated, 2) why FinCom did not warn citizens it would be increasing, and 3) what we can do about it. As you know from your time in service on the Select Board, the Finance Committee has little control over the variables affecting the tax rate and making predictions with any specificity is risky. Two of our committee members have tried to explain the variables and the Finance Committee's role and responsibility, but the person does not seem appeased. This person is also highly agitated about the MLB and how it is operating and why the Finance Committee isn't providing better oversight.

I recommended this person get an audience with the Select Board to determine what action they could take to improve their situation and the other seniors they claim to represent. It seems to me this person wants someone else to champion their fight. This is not my fight, and I wouldn't have the bandwidth to lead the charge even if it were. However, I do care about Heath seniors and I do care about citizens being accurately informed. To that end, I was wondering if the Council on Aging would want to set up any informational meetings for their members where Ned and I would come and address the group on the role of the Finance Committee, how taxes are levied, how the tax rate is calculated, and answer any questions we can related to the operating costs of the town and the work of the MLB.
