

#### (1) Applicant Qualifications and Project Description:


The Town of Heath has been an active member in the Mohawk Trail Woodlands Partnership (MTWP) and is committed to furthering the goals of the Partnership. Recently the Town of Heath acting through its Parks and Recreation Committee, was awarded a grant from Executive Office of Energy & Environmental Affairs ("EEA") for the development of the Burnt Hill-Catamount Trail (the "BHC Trail") Development Project which is currently underway. The BHC Trail was envisioned to provide public access on town conservation land to connect it with existing State Forest lands. While the BHC Trail project has improved access across Heath's Conservation land, the trail still lacks direct public land access to the Catamount State Forest. The purpose of this grant application would be to solve this limitation by acquiring an 11.2-acre parcel of privately-owned land, abutting Town Conservation Land and the State Forest land (see Map 1 below). This Project to be known as the "Heath-Catamount Public Land Corridor Project" (the "Project"), will create a direct publicly owned land bridge between the 350-acre Town-owned Shapiro-Burnt Hill Woodlands Conservation Area to the 1,338-acre Catamount State Forest. It will also result in the addition of 11.2 more acres of conservation land for the Town of Heath.

The Project will involve the acquisition (through a friendly sale with its current owner) by the Town of Heath of the uniquely shaped 11.2-acre parcel pictured above in Map 1. The parcel is entirely within the Town of Heath and is currently owned by a descendent of the original settler of the land in 1790. Given this unique history, current owner is eager to see the parcel preserved for public recreation access and has agreed to work with the Town on this Proposal. After acquisition the parcel would then be dedicated by the Town of Heath as new conservation land. Thereafter, the Heath Parks and Recreation Committee would use Committee members and community volunteers to clear a new hiking trail on the parcel. This

would result in the creation of a new trail segment (illustrated in Map 2 below) that would become part of the BHC Trail and provide direct public access into the Catamount State Forest and the existing network of DCR trails therein. The long-term maintenance of the newly acquired conservation land as well as the new segment of the BHC Trail will be provided by the Heath Parks and Recreation conjunction with the Town.

As illustrated in the Map above, the Project will facilitate the extension of the existing BHC trail from its current terminus at the property line of the Shapiro Conservation Land where it intersects with the Franklin Land Trust's Sunrise Farm Trail Easement (the Sunrise trail exists on private property and does not directly link up with DCR trails in the Catamount State Forest).

The Project is located on the eastern border of Heath, western border of Colrain, and northeastern border of Charlemont, an in area comprising one of the largest stands of uninterrupted forest in Franklin County and perhaps the State. This Project will create new public land corridor ensuring recreational access across the Burnt Hill-Catamount Trail in perpetuity, greatly improving public access to this large forest resource. Once completed the BHC Trail combined with existing DCR Trails in the Catamount State Forest, will provide approximately 6.5 miles of hiking trails across thickly forested public lands uninterrupted by roadways or structures. The Heath-Catamount State Forest Public Land Corridor Project will provide the lynchpin to ensure recreational access for the public in perpetuity and thereby furthering the goals of the Mohawk Woodlands Partnership.

#### (2) Project Task List and Implementation Timeline:

The Heath-Catamount Public Land Corridor Project will be completed in two phases during 2020-2021, with both stages being completed by the July 31, 2021. The first phase of the project will involve the acquisition of the 11.2-acre parcel from its current owner. Given that the acquisition of land and its subsequent dedication as conservation land requires Town Meeting approval, the Parks and Recreation has moved to include this proposal on the Annual Town Meeting warrant. Given the Covid-19 crisis, Heath's Annual Town Meeting has been rescheduled several times already and is likely to take place either in late July 2020 or September 2020. Despite these scheduling challenges, the proposal has been warmly received in town and Parks and Recreation does not anticipate any obstacles to approval at Town Meeting. The Parks and Recreation Committee has been working diligently with the current owner to facilitate a smooth transfer of ownership within the timeline required under this Grant Application. The Town of Heath will retain Special Town Counsel (included in the grant budget below) to facilitate the sale of the land to the Town and its subsequent dedication as Conservation Land. It is anticipated that the conveyance to the Town should be completed by October 2020, depending upon the timing of the rescheduled Annual Town Meeting.

The Second Phase of the project will begin after acquisition of the parcel has been completed. Beginning in late fall of 2020 and continuing into spring of 2021, the Heath Parks and Recreation Committee will begin work on extending the BHC trail. Utilizing volunteer labor, Parks and Recreation Committee will over the course of several socially distant "Trail Day Work Bees," will build out the new segment of the BHC trail. This trail work will include the installation of water bars, trail signage, a trail map and markers and will be completed well in advance of July 31,2021. No building permits or conservation commission approvals are anticipated in either Phase I or Phase II of this Project.

### **Key Project Implementation Milestones:**

- Phase I Land Acquisition Enter into Letter of Intent (precursor to Purchase and Sale Agreement) with Current Landowner July/August 2020
- Approval of Town Meeting for Acquisition & Dedication of Conservation Land Late July/September 2020
- Execute Purchase and Sale Agreement September 2020
- Conveyance of Land and Recording of Deed/Title, Recording of Conservation Restriction October 2020
- Fall 2020 and Spring 2021 Phase II- BHC Trail Extension Project "Trail Day Work Bees"
- Completion of Phase I and Phase II July 2021

# (3) Project Budget:

It is anticipated that the total costs for Heath-Catamount Public Land Corridor Project will be \$19,450.00. The Project will be funded entirely by the Mohawk Woodlands Implementation Grant on a reimbursement basis in accordance with the terms of the Grant Agreement.


