

MEETING MINUTES

Town of Heath

SELECT BOARD

Virtual Meeting Only

Tuesday, January 13, 2026

Called to order at 5:00PM with Robyn Provost (Chair), Elissa Viarengo (Member), and Mia Francesconi (Town Coordinator) present.

Others present included Barbara Gordon, Michael Cucchiara (Parks & Recreation Committee), Patricia McGahan, Ned Wolf (Finance Committee), Robert McGahan, Brian DeVries (Energy Advisory Committee), and Bob Dane (Parks & Recreation Committee).

R. Provost announced that the meeting was being audio recorded.

Review Agenda Added: Office Assistant Proposal; Hilma A. Sumner Resignation Letter

5:00 p.m. Appointment: Parks & Recreation, Mike Cucchiara – Update on Activities

M. Cucchiara asked the Select Board to sign contract paperwork for a grant that the Parks & Recreation Committee was awarded to resurface the basketball/pickleball court in the center of Town. The Select Board reviewed the documents and noted some issues. These issues included the designation of the area on which the basketball/pickleball court was situated as a public park, the source of the matching funds, and the timeline for the project. The Select Board decided that they did not have enough information to sign the documents and tabled the signing of said documents to their next meeting.

M. Cucchiara then asked the Select Board to order that the Conservation Commission issue notices of non-compliance ahead of issuing enforcement orders. The Board noted that they did not have the authority to order that the Conservation Commission do that, though they could make it a suggestion. The specificities of the Enforcement Order that was issued to the Town of Heath regarding the Burnt Hill-Catamount Trail culvert replacement were then discussed. The Select Board directed M. Francesconi to obtain quotes from local wetlands consultants to aid the Town in the remediation process.

M. Cucchiara stated that he had installed the signs on the way-finding kiosks. These kiosks were funded through a Woodlands Partnership grant in fiscal year 2025. He will be emailing M. Francesconi photographs of the newly installed signage so that she can close out the grant with the State. M. Francesconi then referenced a complaint that she had received from a resident in the center of Town stating that at least one of the kiosks was in violation of the *Protective Zoning Bylaws of the Town of Heath, Massachusetts*. Members discussed this with B. Dane and M. Cucchiara, ultimately instructing B. Dane to look for a new location for the kiosk in the center of Town and asking the Parks & recreation Committee to apply for a Special Permit from the Planning Board for the same kiosk. R. Provost requested that M. Cucchiara provide the Select Board with a list of grants received by the Parks & recreation Committee along with the status of each grant. She then instructed M. Francesconi to consult the Town's legal counsel for their interpretation of the alleged kiosk zoning violation and how the zoning bylaws apply to signage owned by the Town that is located on Town right-of-way.

P. McGahan informed the Select Board that she would be organizing for ping pong to be played in the Cafeteria on Monday nights. She was not sure how many people would be playing.
