8.5.3 A special permit to keep more than two (2) unregistered vehicles, on any premises, may be granted by the Board of Health Select Board. All such permits granted shall not run with the land or be granted in perpetuity.

8.5.4 Enforcement:

(1) This bylaw may be enforced by any Town police officer or agents of the Town's-Board of Health.

(2) Whoever violates any provision of this bylaw may be penalized by a non-criminal disposition process as provided in M.G.L. c. 40, § 21D and the Town's non-criminal disposition bylaw. If non-criminal disposition is elected, then any person who violates any provision of this bylaw shall be subject to a penalty in the amount of ten dollars (\$10.00) per day for each violation, commencing thirty (30) days following date of receipt of written notice from the Board of Health the Select Board or its designee. Each day or portion thereof shall constitute a separate offense. If more than one, each condition violated shall constitute a separate offense.
